- c. To pay and utilize balance of such interests, dividends, rents grants and other income of the Trust fund (hereinafter called 'the net income of the Trust Fund') and if Trustees so desire the corpus of the Trust or any part of the corpus for all or any one or more of the following charitable purposes and objects of the Trust in such shares and proportions and in such manner in all respects as the Board of Directors in its absolute discretion think fit without distinction of place, nationality, caste, creed, or religion.

## **7. AIMS AND OBJECTIVES OF THE TRUST:-**

Without prejudice to generality of the objects or purposes but subject aforesaid it is declared that the trustees shall always be under obligation to expend, apply or release the corpus and/or income of the Trust towards the execution of the carrying out only such of the objects or purposes herein below mentioned which according to law be public charitable objects or purposes, to the exclusion of the other or others of them and in such proportion, order and in such manner in all respects and to such extent as the Board of Directors may think fit and proper so however that, any money of the Trust shall not be spent for the benefit of any individual as such, as far as possible, unless TRUSTEES otherwise agree.

The aims and objects for which the trust has been created are as follows:-

### **A. MEDICAL EDUCATION:-**

To spread medical education in all respects viz. in all branches and spheres of Medical Science in such manner as the Trustees may think proper and for that purpose :-

- a.** To establish, support, maintain, organize, run and or to assist through Medical Aid and Assistance Centers imparting information regarding Health and Hygiene in pre-primary, primary, Secondary schools, colleges, study centers and other Institutions imparting secular education and knowledge.
- b.** To award Scholarships and Fellowships on such terms and conditions as the Board of Trustees may think fit for the Purpose of undertaking, prosecuting and encouraging education, higher education and research work in any branch of medicine, surgery, modern medicine in its widest and more comprehensive sense.



c. To run various courses to train teachers who would be able to impart or conduct proper Medical aid and assistance independently in various rural parts of India.

d. To establish, assist, promote, encourage and maintain, in various parts of India primarily in District Dhule in Maharashtra and abroad, for teaching theory, practice and/or principles of all the branches of medicine including allopathic, homeopathy and Ayurveda or any other system or medicine, which is deemed proper or expedient for the purpose of medical relief in general by way of-

1. Establishing medical schools and colleges, Pharmacy colleges, and Nursing Midwifery Classes for imparting medical education and training in all its spheres.
2. Institutions for promoting medical research work.
3. Nursing institutions and Convalescent homes.

e. To conduct conferences, seminars, symposiums, refresher courses, lectures, demonstrations, exhibitions for the members of medical fraternity and/or public at large and/or to print, publish, exhibit or subsidies the publication of books, magazines, pamphlets, posters, circulars, pictures, photographs related to and/or the awareness of health and medical assistance.

f. To establish Ambulance Corps with or without Classes for imparting education and training in ambulance work.

g. To do all such other lawful things as are incidental and conducive to the attainment of any of the above purposes and as shall be declared by the Board of Trustees.





**B. MEDICAL AID AND ASSISTANCE**

- a. For reception and treatment of persons suffering from physical and mental illness or for providing medical and allied facilities to persons during convalescence and for taking care of persons requiring medical attention and rehabilitation and for detection, prevention, and curating of any diseases including T.B., Cancer, AIDS and to organize programs for eradication of Polio and for that purpose and as a part of it to establish, organize, set up, maintain, manage, run, conduct and to support, assist or give aid to, either in cash or in kind or collaborate with hospitals, nursing homes, dispensaries, clinics, health centers, convalescent homes, crèches, medical centers, including all auxiliary and supporting units.
- b. To give donations to Dispensaries, Hospitals, Nursing Homes, Orphanages and such other Public Medical Institutions giving medical aids to needy people, upon such terms and to such extent and for such period as the Board may deem fit.
- c. To procure the services of doctors, surgeons and/or medical practitioners, practicing or providing medical aid from any of the branches of medicine, Medical Assistants, Trained-Untrained Workers, Attendants and Servants either for remuneration, gratuitously and/or in any other honorary capacity.
- d. To expend the funds of the Trust in sending deserving patients to and maintaining them in convalescent and other similar institutions including Private and Charitable Hospitals, in such a manner and to such an extent as may, from time to time, be deemed, expedient and in paying the expenses or part of the expenses for such patients, and in sending such patients to their homes or elsewhere.

e. To undertake the management and conduct of institutions, hospitals, nursing homes, health and medical aid centers, clinics and similar organizations having similar objects or otherwise.

f. To distribute free food, clothing, medicines and provide shelter and other necessities of life to poor and needy persons affected by poverty and such natural calamities like famine, flood, earthquake or any other unforeseen calamities like riot, war or war like situations.

g. To provide drinking water facilities or to support development of such drinking water facilities wherever there is contamination and/or scarcity of water so as to minimize the hardships caused to the residents and particularly to the women and aged persons in rural areas and urban slums due to **diseases spreading** by such water and for that purpose to install pump-sets, to dig wells and to lay pipes for supply of drinking water.

h. To undertake and arrange welfare activities and rehabilitation of physically handicapped, mentally retarded and addicts.

i. To undertake promote, sponsor, encourage, assist, give aid to and co-operate with family welfare activities and to educate and motivate the people for family planning.

j. To establish Ambulance Corps, with or without classes for providing service in emergency situations.

k. To provide medical help in all possible and suitable manners depending upon circumstances and situation to poor, deserving people of the weaker section of the Society.

l. To do all such other lawful things as are incidental and conducive to the attainment of any of the above purposes and as shall be declared by the Board of Trustees.



**C. MEDICAL RESEARCH :-**

- a. To try and adopt the modern techniques of medicine by way of collaborating with the Research Institutions in India and abroad which will reduce the cost and period of treatment of the diseases known and to facilitate treatment on the diseases alien to the medical fraternity.
- b. To promote a scientific and medical research work amongst the undergraduate, graduate and post graduate students, teachers, professors in medical colleges, universities or otherwise the Foundation may arrange to give research grants, freeships, scholarships, loan scholarships, prizes, etc. as may be deemed expedient from time to time.
- c. To promote, develop and improve scientific exchange of knowledge as well as technical co-operation between research institutions with similar interests and objectives.
- d. To do all such other lawful things as are incidental and conducive to the attainment of any of the above purposes and as shall be declared by the Board of Trustees.

Provided however that, if at any time hereinafter it is held that any of the objects or purposes aforesaid for which the Corpus and/or income of the Trust Fund or any part thereof hereby directed to be applied or expended are not charitable according to the law relating to Income Tax Act then in force, so as to exempt the Trustees of this Trust from the payment of Income Tax on the Trust, the Trustees shall expend the Corpus and/or income towards the execution of and carrying out only such of the objects and purposes aforesaid as may be held to be strictly charitable according to such law to enable the Trustees of the Trust to qualify for and secure such tax exemption.

**8. TRUST NOT FOR THE PURPOSES OF PROFIT:-**

The Trust shall exist solely for philanthropic purposes and not for purposes of profit. Any income or surplus derived by the Trust when so ever and from where so ever shall only be incidental and shall be applied solely for attainment and promotion of the objects of the Trust set forth in these presents and it shall not be distributed, directly or indirectly by way of profits, dividends, bonus or otherwise to the settler or any of the Trustees or Donors.

Provided however that nothing contained herein shall prevent the Trustees from reimbursing themselves out of the Trust Fund all bona fide expenses that may be incurred by them jointly or severally in or about the execution of the Trust purposes and other reasonable expenses incurred for the purposes of the trust.


**9. MANAGEMENT OF THE TRUST AND VESTING OF THE PROPERTY:-**

All the Trustees of the Trust together shall form the Board of Trustees (hereinafter referred to as 'the Board'). The Board shall manage the Trust and the Trust Fund shall vest in the Board subject to the provisions hereinafter contained.

**10. CONSTITUTION OF THE BOARD:-**

The Board shall consist of minimum 7 Members and maximum 21 members who shall be appointed as under:-

a. First Trustees i.e. Founder Trustees are appointed by the Settler in view of the formation of the Trust. The remaining Trustees shall be nominated by the BOARD OF TRUSTEES of the CHANDRAKANT KELE MEDICAL AND RESEARCH FOUNDATION and preferences as far as possible shall be given to the person having experience in managing or

working with any Trust or Foundation or willing and enthusiast person/s.

b. The tenure of Trustees so nominated or appointed shall be in accordance with the provisions contained in Clause-13 given below.

c. The BOARD OF TRUSTEES shall always consist of Minimum 7members/Trustees. It is not a condition precedent to have 21 Trustees on board at a time. They can be appointed as and when felt necessary by the existing Board of Trustees.

d. In case any such Trustee appointed herein becomes non-eligible to be a Trustee or refuses to act as a trustee of the Trust by virtue of his position in accordance with applied laws of land or in case any Trustee resigns from his/her Trusteeship or otherwise, in that case the Board of Trustees shall nominate *any other member* of their Choice as a trustee in his/her or their place to fill the vacancy occurring there from then, subject to approval for his/her/their name/s by all the members, provided however the member so nominated shall hold office of trustee for the period for which the trustee in whose place he had been appointed/nominated would have held the office.

#### **11. OFFICE BEARERS OF THE TRUST:-**

##### **i. CHAIRMAN:-**

The Board shall elect from amongst themselves the Chairman.

##### **A. CHAIRMAN OF THE MEETINGS:-**

The Chairman shall preside over all the meetings of the Board. In the absence of the Chairman, trustees present at the meeting shall elect the Chairman from amongst themselves for the meeting. Such

Chairman shall exercise all the powers of the Chairman for conducting the meeting.

**B. POWERS AND DUTIES OF THE CHAIRMAN :-**

The Chairman shall preside over, conduct and regulate all the meetings of the Board. His rulings on any point, order and decision as to the results of voting shall be conclusive and final. The Chairman shall have the authority to interpret the Rules for the purposes of the conducting and regulating the meetings and deciding the question of meeting.

**C. CASTING VOTE:-**

The person who chairs the meeting shall be entitled to a Casting Vote in case of tie.





**A. ADMINISTRATIVE:-**

1. To supervise the working and management of the Trust and/or all the Institutions of the trust and carry on all correspondence and keep and preserve and/or cause to be kept and preserve properly all the records of the Trust including the books of account, vouchers, correspondence etc. And prepare or cause to be prepared and place before the Board. Such material and information as may be necessary from time to time, or produce the same if and whenever required by the Member(s) of the Board and/or before any Government, Semi-Government and/or other Statutory Authorities.
2. To deal with all matters regarding the scales of salaries, promotions, increments, extension of services, dismissals, punishment of employees of the trust subject however to confirmation of the Board.
3. To recommend to the Board any proposals relating to:-
  - I. Management and Supervision of the Trust.
  - II. Investment of the Trust Fund as stipulated in Income Tax Act, 1961 and B.P.T. Act, 1950.

**B. SECRETARIAL:-**





**13. CESSATION OF THE TRUSTEESHIP:-**







- r. To co-operate or collaborate with any other institution having objects altogether or in part similar to those of the Trust.
- s. To seek affiliation, or to subscribe to and/or become member of or co-operate with any other Trusts, Societies, Bodies of Persons, Association of persons, Institutions, Bodies Corporate including companies limited by guarantee having objects similar to those of the Trust.
- t. To formulate, approve, submit, authorize any scheme or schemes for the management of the trust property and for carrying on or promoting the objects of the trust.
- u. Income Tax Officer, Commissioner of Income Tax, Income Tax Appellate Tribunals, Customs Officers, Assistant Officers and Tribunals Customs Officers, Assistant Officers and Tribunals and before any Registrar or Sub-Registrar of Assurances at any places in the Union of India and to present and lodge any documents for Registration and admit execution thereof and to compound all actions suits and other proceeding and all differences, disputes or demands to arbitration and adjust, approve and settle all accounts relating to the society fund and to execute all releases and discharges and to do all other things relating thereto.

#### **16. HOLDING OF OFFICE BY TRUSTEES PROHIBITED:-**

## **17. MEETINGS:-**



**18. THE BANK ACCOUNT:-**



In these circumstances only the Trust can be dissolved.
